Conflicts That Shaped Dallas -- Sixteenth Annual *Legacies* Dallas History Conference

The organizers of the Sixteenth Annual *Legacies* Dallas History Conference welcome proposals from both professional and lay historians on topics related to the theme: "Conflicts that Shaped Dallas."

Although "the Dallas way" has often been to avoid conflicts, in fact disagreements—sometimes loud and prolonged—have been central to the growth and development of the city. Debates over the form of city government (commission vs. city manager, single-member districts, etc.); civil rights; expansion of the highway system; development of the Trinity River corridor; liquor by the drink; the status of Love Field; the preservation of historic neighborhoods—these and many more conflicts merit research.

All papers must be based on original research and must not have been presented or published elsewhere. The best papers will be published in a subsequent issue of *Legacies: A History Journal for Dallas and North Central Texas*. Those interested in presenting papers should submit a brief summary of their proposal by JULY 1, 2014, to "Dallas History Conference, 1515 S. Harwood St., Dallas, TX 75215," or by email to: mvhazel@sbcglobal.net. Those selected will be notified by August 1, 2014.

The Sixteenth Annual *Legacies* History Conference will be held on Saturday, January 31, 2015, at the Hall of State in Fair Park. The Dallas County Pioneer Association is one of a dozen historical organizations and libraries that jointly sponsor the conference each year.



Fake Funeral Notice Scam “Reaches a New Low”

In his line of work, funeral home director Brian Bass has come to expect the occasional juvenile phone prank. But the hoax recently perpetrated on the small-town Eubank Funeral Home where Bass works is bigger than any adolescent antics. Cybercriminals hijacked the funeral home’s identity as part of a worldwide email phishing scam.


For the past month, inboxes across the United States and beyond have been getting funeral notices that appear to be from Eubank Funeral Home in Canton, Texas, 60 miles east of Dallas. Without saying who has died, the fake emails invite the recipient to an upcoming “celebration of your friend’s life service” and instruct the recipient to click a link for “more detailed information about the farewell ceremony.” “It reaches to people’s curiosity and their natural instinct to find out who passed away,” Bass told Yahoo News.

But instead of going to Eubank’s website, the Better Business Bureau says, the link in the email takes readers to a foreign domain where malicious software is downloaded onto the user’s computer allowing criminals access to passwords, financial records, and other personal information stored on the computer. “This scam email, disguised as a funeral notification, reaches a new low,” the Better Business Bureau said in a nationwide warning last week. “Scammers are always on the hunt for new ways to evade the delete button.” It’s unknown how many people have fallen victim to the hoax, but Bass said Eubank Funeral Home has received 50 to 100 complaints a day since mid-January. Calls and emails have come from as far away as Finland and South Korea.

“We filed a police report and our security people are in touch with the government, but nobody can stop it yet,” Bass said. The ordeal forced the funeral home, which has been in business for 88 years, to remove its phone number from its website and post disclaimers and warnings about the scam. Dallas City Parks - Eloise Lundy Park



George Kessler’s plan for the city of Dallas called for more parks and playgrounds. The black community petitioned the City of Dallas for a park for blacks somewhere in Dallas. When the \$500,000 bond issue in 1913 was approved by the voters land for seven parks was bought.

Two of these seven parks were for blacks, one in Oak Cliff and one on Hall and Central in Dallas. The land for the first Oak Cliff Negro Park that the Park Board selected is on Sabine and Cliff. This was ten lots in the original Town of Oak Cliff that was annexed to Dallas in 1903. In the 1920s about one half of the original park was absorbed by the Trinity River levee.

For many years this park was a playground and minimum improvements were made. There was a band concert in 1916 and free movies were shown in 1931. In 1935 a supervisor was assigned to work

with the citizens at the park. A study made in 1939 showed that the parks serving Negroes were in bad condition and crowded since they were too small to serve the community.

In 1941 a shelter was erected, a Junior pool was added, new play equipment was installed and construction of a tennis court and a comfort station were provided for this site. The name of the park was changed in the 1950s to Eloise Lundy a long time employee of the park department. She had worked at Exline Park for eighteen years and was one of the first three black female park supervisors in the city.

November – December 2013: Prepare a partial list of the pioneer families that will be of interest to the D Magazine readers. Some progress has been made.


January – February – March 2014: Provide research material and complete the list of families.
